AlQuds index declined this month with the total trading value of (30.26) points which is a low of (5.94%) compared with last months closing level of (479.43) points. Its trading value this month amounted to (\$42) million, a low of (46.37%) compared to last June, out of (10,731) contracts carried out through (23) trading sessions. The number of traded shares also retreated by (57.52%) amounting to (15) million shares.

This months market trades focused on the banking sector which won over the rest of the sectors in terms of its trading value. It formed more that (76%) of the total PSE trading value. The share of (BOP) achieved a gain of (5.13%) closing at (\$4.30) and and a total trading value of (6.29) million shares valuing (\$26.74) million. It formed more than (63%) of the total PSE trading value and more than (92%) of its sectors trading value.

As for (QUDS) share, it dropped by (8.92%) and closed at (\$1.43) after trades of (30) thousand shares took place, valuing (\$50) thousand. The (AIB) share also descended by (1.01%) closing at the level of (\$1.96) after trades of (0.86) shares valuing (\$1.68) million took place.

The investment sector formed (14.58%) of the total PSE trading values overall where as (PADICO)'s share declined by (3.79%) closing at (\$2.03) with a total trading value of (2.42) million shares which valued (\$5.09) million.(UCI)s share fell back by (15.53%) after closing at (\$0.87) and a total trading value of(3.00) million shares valuing (\$2.92)million. Also, the share of (PIIC) declined by (5.81%) and closed at (0.81)JD with a total trading value of (0.11)million shares valuing (\$0.13) million.

As for the service's sector it formed (5.51%) of the total PSE trading value. The share of (PALTEL) suffered a decrease of (6.43%) closing at (3.93)JD and traded (0.43) million shares valuing (\$2.48) million.(WASSEL) also retreated by (8.82%) closing at (0.93)JD with a total trading value of(0.19) million shares which valued (\$0.26) million.(PEC) share lost by (2.75%) closing at the level (\$1.06) and traded (0.20) million shares valuing (\$0.22) million.

Featured News of the Month:

- An agreement was made between the Palestinian Investment Fund, OPEC and The Aspen Institute to launch a program for loan guarantees to the private sector in the West Bank and Gaza Strip. The program is more than (\$228) million with a (10) year duration period. This took place in the Ramallah presidential headquarters in the presence of President Mahmoud Abbas.Under this agreement the American Institute provides (\$110) million and the Investment Fund provides (\$50) million, this in a form of guarantees by (70%) for loans provided by banks operating in the Palestinian Territories for SME's which constitute more than (90%) of the Palestinian economy.

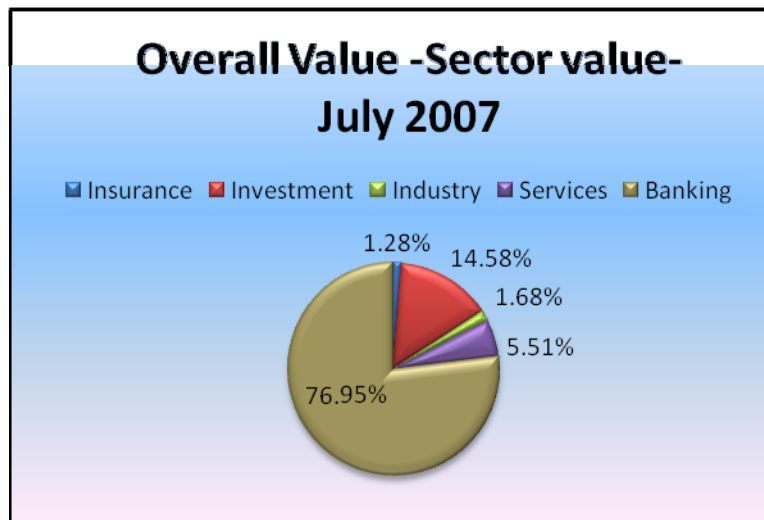

- The Bank of Palestine celebrated the opening of a new branch in the village of Dora, south of Hebron. This brought the number of its nation wide spread branches to (30).
- The (BOP) board of directors announced its net profit, before taxes, for one month, which is June 2007, amounting to about (\$2.82) million.
