

Total income of industrial companies amounted to \$14.99 million in 9M 2014

Total profits of the companies constituting the industry sector in the Palestine Exchange reached \$ 14.99 million in the first nine months of 2014; down by -29.66% compared to the corresponding period of the year 2013.

Among the sectors' results:

- The Vegetable Oil Industries Company VOIC accounted for 37.11% of the total sectors' net income.
- The National Aluminum & Profile Company NAPCO reported the largest growth rate in the bottom line; by 11.37%.
- 4 companies out of 12 companies reported positive change in net income, while 6 companies reported lower profits.
- 2 of the sector's companies have realized losses for the period.
- In terms of market indicators, The Vegetable Oil Industries Company VOIC reported the lowest forward PE ratio of 5.74x, while this ratio varied between 97.00x and 5.74x in the sector.
- Al-Shark Electrode Company ELECTRODE reported the lowest P/BV ratio of 0.49x, while this rate varied between 1.87x and 0.49x.
