

Total income of services companies amounted to \$80.71 million in 9M 2014

Total profits of the companies constituting the services sector in the Palestine Stock Exchange reached \$80.71 million in the first nine months of 2014; down by 6.59% compared to the corresponding period of 2013.

Among the sectors results:

- Palestine Telecommunications Company PALTEL accounted for 113.96% of the net income (profits minus losses), and 97.81% of the total profits.
- Arab Palestinian Shopping Centers PLAZA reported the largest growth rate in the bottom line; reducing its losses by 74.92%
- 4 out of 12 companies reported positive change in the net income,
 while 5 companies have reported lower profits or higher losses.
- 7 companies realized losses for the period.
- In terms of market indicators; Palestine Telecommunications Company PALTEL reported the lowest forward PE ratio of 8.17x while this ratio varied between 8.17x and 246.55x excluding companies that reported losses.
- GLOBALCOM Telecommunications GCOM reported the lowest P/BV ratio of 0.11x while this rate varied between 0.11x and 2.24x in the sector.
